Every year, the Franklin County Office on Aging (FCOA) receives grant funding to provide specialized services to older adults so they can optimize their ability to live and function in the community. For the 2023-2027 levy cycle, the Franklin County Office on Aging will realign how it awards grant agencies to ensure they fund projects that result in healthy outcomes by touching one or more domains in the social determinants of health (SDoH). Social Determinants of Health

The Centers for Disease Control and Prevention (CDC) defines social determinants of health (SDoH) as conditions in which people are born, grow, live, work and age and these factors impact health and overall quality of life. The CDC categorizes SDoH as: Healthcare Access, Education Access, Social and Community Context, Economic Stability, and Neighborhood and Built Environment.



1. Education Access and Quality

Education access and quality includes determinants such as varying levels of education and vocation that can lead to higher literacy and stable income.

2. Health Care and Quality

Healthcare access and quality includes determinants such as insurance, treatment, and preventive healthcare measures.

3. Neighborhood and Built Environment

Neighborhood and built environment include determinants such as safe housing, access to transportation, and availability of healthy foods.

4. Social and Community Context

Social and community context includes determinants such as safety, positive relationships, and community support.

5. Economic Stability

Economic stability includes determinants such as affordable housing, food security, and employment.

Description: The Specialized Program Assessing Resource Connectivity (SPARC) connects Columbus Division of Fire (CFD) paramedics with social workers from the Central Ohio Area Agency on Aging imbedded at CFD. Emergency Medical Services (EMS) make referrals to the social workers as a coordinated response to non-emergency or frequent utilizers of EMS who are in need of but, often, do not have access to other resources. SPARC will provide assistance to these vulnerable individuals who call 911 and may be experiencing unmanaged chronic illness, mental or behavioral health conditions, addiction, homelessness, hunger or other issues. SPARC will provide assistance by connecting these individuals to the appropriate healthcare system, social service agencies or other resources to address their needs.

Description: The Prescription Access Program provides medicine and pharmaceutical services to income-eligible seniors in Franklin County. Regular visits include no cost medication, health assessment on clinical markers (e.g., blood pressure and blood glucose monitoring), medication counseling, health education on diet and lifestyle modifications, referrals to available non-health related community resources, chronic disease management, and access to free healthy produce. Patients are qualified for 12 months of no cost medication and pharmacy services at one of two locations:

LifeCare Alliance's Community Wellness Centers are staffed with registered nurses and registered dietitians experienced in the needs of seniors, and work as a team to monitor and maintain participants' good health.
